POLICY AND PROCEDURE

Internal Complaint Committee:

At Kashi Institute of Pharmacy, an internal complaint committee has been established. To address the matter in accordance with Section 4 of the Sexual Harassment of Women at the Institution (Prevention, Prohibition and Redressal) Act, 2013, which was released by the Ministry of Women Welfare, Government of India, in order to address the concerns of all Kashi IP staff members and students.

Objectives of ICC Committee:

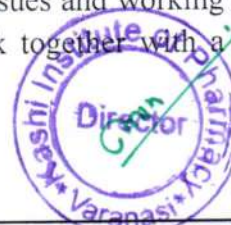
1. To establish an ongoing procedure that the organization can utilize to stop and deal with instances of sexual harassment and other types of gender-based violence.
2. To create an institution-wide policy prohibiting the sexual harassment of women.
3. To establish a secure and safe space in order to stop any instances of sexual harassment.
4. The institution is dedicated to preserving a discrimination-free atmosphere based solely on gender.
5. To encourage a psychological and social milieu that will increase consciousness regarding sexual harassment in all of its manifestations.
6. To ensure that, by appropriately reporting complaints and investigating them, the policy is carried out in compliance with both the text and the spirit of the law.

Role and Functioning of the Committee:

After receiving a complaint, the ICC will begin a preliminary investigation to ascertain the veracity of the allegations by compiling supporting material and interviewing any witnesses, including the complainant. ICC is then required to forward to the Director the preliminary inquiry report and any original documents collected during the preliminary enquiry proceedings. Where necessary, the ICC may file complaints with the other sections or the Grievance Redressal Cell if the accusations are not sexual in character. Female Students and staff of Kashi Institute of Pharmacy, Varanasi may email their complaint or made a phone call or written request to any ICC committee member.

Responsibilities of the Committee:

1. Ensuring that no one will learn the complainant's identity.
2. To create and uphold a workplace free from sexual harassment, including safeguards against co-workers and outside guests.
3. Increasing understanding of gender and sexuality-related issues and working to provide a welcoming atmosphere for gender justice, where all parties can work together with a feeling of security and dignity, are examples of gender sensitization.
