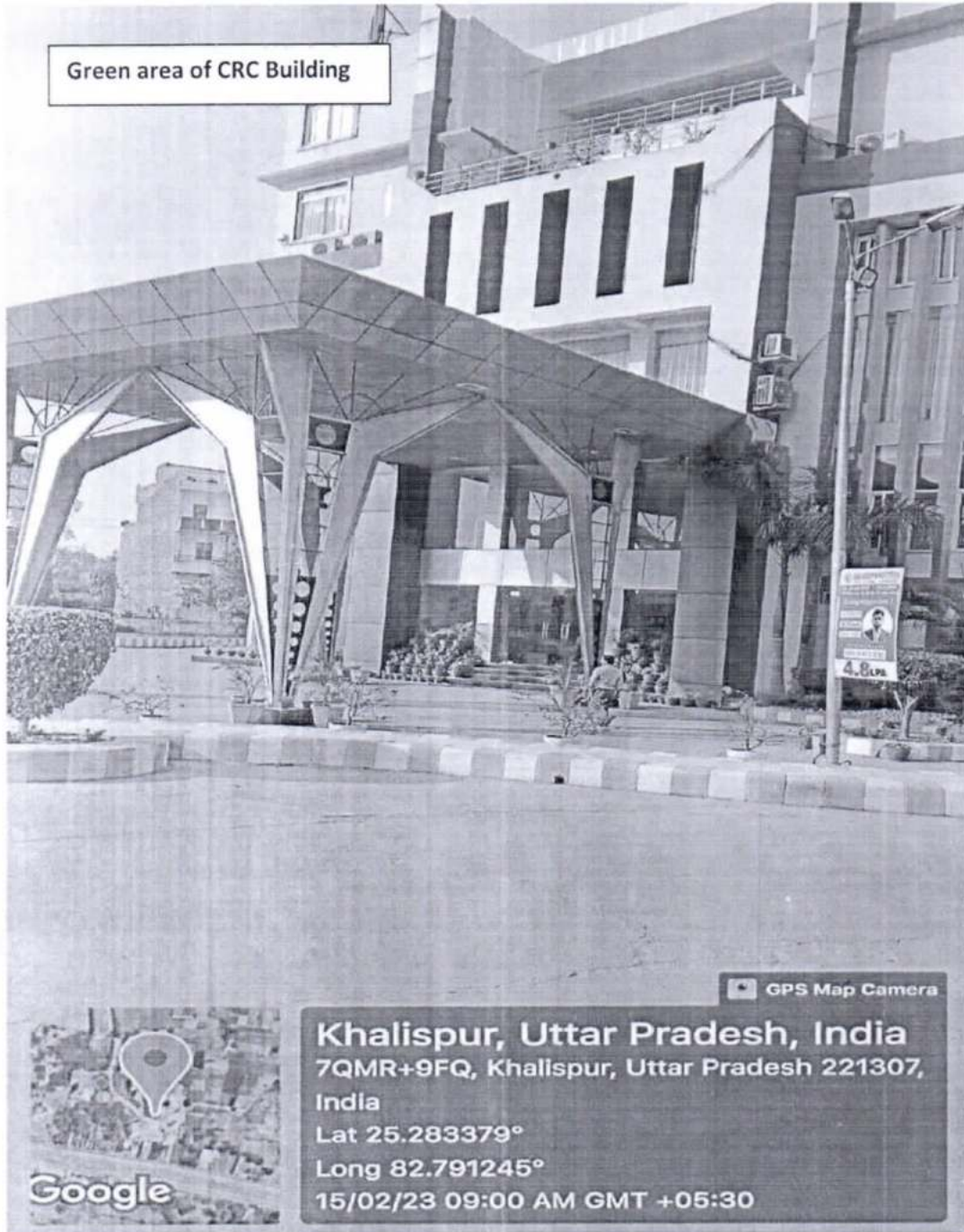




Front area of CRC Building

In the meeting following decisions were made

- Proper aeration treatment should be done, such as hollow coring followed by top dressing allows 'soil exchange' whereby poor compacted soil is in part replaced by free draining mixes of soil and sand.
- To consider on an annual basis the budget can be set and controlled by the committee.
- To determine the daily work programme and allocate tasks to the green staff accordingly.
- A weekly check should be carried out on the boundary fences or walls, and repair as needed.
