The meeting was chaired by Mess/ Canteen In-charge. The following agenda discussed in the meeting is listed below.

### 1. Standardization of Food Portion Sizes

The issue of inconsistent food portion sizes was raised. The committee discussed how variable portion sizes were affecting student satisfaction and leading to food wastage. It was agreed that uniform portion sizes should be standardized across all meals.

# 2. Review of Hygiene Inspection Reports

The hygiene inspection reports were reviewed, and overall the hygiene standards were found to be satisfactory. However, minor improvements were suggested for deep cleaning in certain kitchen areas. The importance of routine hygiene checks was reiterated.

# 3. Discussion on the Introduction of seasonal vegetable Options

There was a strong consensus on the need to expand the menu to include more vegetable options, given the growing demand for plant-based meals. The committee also discussed the possibility of offering gluten-free options for students with dietary restrictions.

# 4. Improving Food Delivery Times and Efficiency

Concerns were raised about delays in food delivery during peak hours, leading to longer wait times for students. The committee discussed ways to streamline kitchen operations and improve meal distribution to ensure food reaches students in a timely manner.
